
It took over three years and a successful capital campaign to rebuild after Hurricane Harvey. The new custom designed flood mitigation measures will protect the space from future flood damages.


Committee on Architecture for Health










Community Empowerment Through Health (CETH)


What Your Momma Didn't Tell You About Money


Justice, Equity: Diversity and Inclusivity JE:DI Collective

The mission of AIA Houston's Justice, Equity: Diversity, Inclusivity Collective (JE:DI) is to dismantle the barriers that have inhibited the growth of our profession and our community. The JE:DI Collective seeks justice, builds equity, promotes diversity, and fosters a culture of inclusivity.

In February, the collective partnered with the NOMA, in partnership with the City of Houston's complete Communities Initiative to present Designing for Impact: building hubs and corridors in the Complete Communities. Thirteen design teams engaged with over 300 community members to participate in a threeday design workshop that would help bring ideas from Houston's historically underserved communities to life. The collective is also working with HNOMA in the adaption of SoCal's diversity, Equity and Inclusion challenge for Houston area firms and schools. The initiative provides the tools needed to evaluate and transform themselves. By prioritizing metrics and actionable responses, participating firms can more easily work towards creating a professional environment and a built environment that supports racial justice, social responsibility, diversity, equity, and inclusion.

Houston 2020 Visions

(August 31, 2020 - August 27, 2021)









The Houston 2020 Visions exhibition launched online on August 31, 2020, during the third anniversary of Hurricane Harvey's arrival in Houston. The in-person exhibition debut in November 2020.

The Houston 2020 Visions Lecture Series presented three online panels in 2021 including Prairie-To-Bay Ecology, with Rob Rogers, FAIA, Rogers Partners Architects + Urban Designer and Charlie Penland, PE, Walter P Moore, designers of the proposed Galveston Bay Park; and Mary Anne Piacentini, President & Chief Executive Officer of the Katy Prairie Conservancy. Galveston Bay Park. The April panel, Green Corridors, featured Beth White, Houston Parks Board; Kinder Baumgardner, ASLA, SWA Group; J. David Waggonner, FAIA. The May discussion, Future of the Energy Economy, included Jim Blackburn, Texas Coastal Exchange; Emily Reichert, CEO, Greentown Labs; Bobby Tudor, Greater Houston Partnership; The online exhibition, program schedule and archive of all lectures can be found at www.houston2020visions.org

The project is a collaboration between AIA Houston and the City of Houston, working with a steering committee consisting of member architects, city officials, local universities, and representatives from partner organizations such as the Rice Design Alliance and the Kinder Institute.

Exhibitions and Programming









The Exhibitions and Programming committee presented a series of online and in-person conversations and tours.

In July, George Sexton and Owen Brady of George Sexton Associates, and Neil Patel, AIA and Alissa Chastain of ARO discussed their roles in the recent restoration of the Rothko Chapel in the online program Bringing New Light: 50 years of the Rothko Chapel moderated by Gregory Benjamin, AIA. The online conversation was followed by an inperson tour of the Rothko Chapel, where architectural historian Stephen Fox and Allston Marble of Linbeck gave insight into the restoration process.

In October, the committee partnered with Rice Management to tour the Ion, formally an Art Deco era Sears department store. Rice has transformed the building into a tech-focused collaboration center.

In November, the committee launched a series of tours focused on Houston's outdoor spaces. The series kicked off with a bicycle tour of Buffalo Bayou East. José Solís, Buffalo Bayou Partnership (BBP) Project Manager; and Sarah Elmusrati, and Donna Kacmar, FAIA, from Natalye Appel + Associates Architects shared the BBP's Master Plan East and re-envisioning of the area.




Michael G. Meyers Design & Scholarship Competition











An annual ideas competition with an emphasis on creative problem solving and graphic presentation, the Michael G. Meyers Design & Scholarship Competition is sponsored by the Architecture Center Houston Foundation, the Houston Chapter of AIA and local architectural firms and affiliates. In 2021, we awarded over \$11,000 in scholarships.

Due to COVID-19, the 2021 MGMC program was presented completely online including the annual design and program workshop, a project site visit, interim review, and awards ceremony.

Students were challenged with designing a new mixed-use living community space in the heart of Houston's Montrose neighborhood, adjacent to the Menil campus. The building would have two main components: housing units and community spaces. Projects were due in May and the winners were announced online. Winning projects can be viewed here.

Gingerbread Build-Off

The Annual Gingerbread Build-Off is a fundraising event for Architecture Center Houston and was held at Levy Park in December 2021.

Thirty one teams, including eight high school teams, created masterpieces using 100% edible materials. Spectators were invited to participate in a kids' construction zone and an architecture scavenger hunt around the park!

This year's competition featured a special category, Parks and Rec, in honor of the new location. Top prize went to Goree Architects for "Jurassic Parks and Rec".




